rt and accountancy aren't exactly traditional bedfellows. One usually requires creativity and spontaneity, while the other relies on accuracy and statistics – and numbers, of course. But for AAT Licensed Accountant Georgia Duffee, who has a genuine passion for both, the two disciplines aren't necessarily polar opposites.

Duffee takes her inspiration from the mathematical paintings and drawings of renowned 15th-century Renaissance artist, Leonardo Da Vinci. Da Vinci frequently worked alongside his partner and collaborator, mathematician Luca Pacioli, who is often described as the father of accounting.

"There are a lot of scientific elements to Da Vinci's work," Duffee says. "He would have been influenced by Luca Pacioli, who was thought to be the first to introduce the concept of double-entry bookkeeping."

But in fact, it was merchant Benedetto Cotrugli whose 1458 published work on bookkeeping and accountancy pre-dated that of Pacioli's 1494 work by several decades. Benedetto also inspired the name of Duffee's business, Benedetto Accountants & Tax.

"There's accidental symmetry with the dates too," she says. "Benedetto was born in 1416 and my company was founded 600 years later, in 2016."

Becoming her own boss

Duffee's decision to set up her own practice at just 21 was borne out of frustration with previous accountancy firms. Her first employer never responded to her request for a pay review once she had qualified with AAT. Her second job, although a "wonderful company" initially, changed for the worse when it was bought by a Top 100 firm. Duffee went from managing a 25-client portfolio in a closeknit firm, to working behind the scenes in a departmentalised corporate environment without meeting any clients.

The last straw came when she ended up working six-day weeks in her third job while juggling additional studies. "I took some time off in the end, because it was really getting to me," she recalls. "I hardly saw my family and friends, and my work-life balance was skewed." Duffee hoped she'd return to work refreshed with a new lease of life, but it wasn't to be. "On my first day back, I remember just sitting at my desk thinking, 'I can't do this for the rest of my career'."

It was her turning point. She enrolled on AAT's *Be Your Own Boss* course and the rest is – quite literally – (art) history.

Duffee says that starting her own practice has freed her up to do what she really enjoys, such as rediscovering her passion for the arts. "I've been trying to visit all the famous masterpieces around the world, Georgia Duffee started her own practice, Benedetto Accountants & Tax. in 2016



which I usually do around my birthday. I've seen Leonardo Da Vinci's 'The Last Supper' in Milan, a Van Gogh exhibition at Tate Britain, and I've visited Salvador Dali's house in Portlligat in Catalonia. I haven't seen any Picasso yet, but that's next on my list – I love his artwork."

> the average age down quite a bit," says Duffee. "I absolutely love volunteering there. I've learnt so much from them, and being treasurer helps fine-tune my skills. I'm helping them as much as they're helping me.

Together, we're benefiting other people's lives by making art available to all."

More recently, Duffee started volunteering at personal development events company, Best You Expo, which brings together health and wellbeing companies across the UK to showcase industry best practice.

All this extra work has meant, of course, that Duffee's work-life balance has become rather skewed again. But, as she points out, it's better to have a slightly skewed work-life balance working for yourself than working for someone else. And volunteering is something she's always done.

Her first volunteering stint at age 13 was in a local shop. Since then, she's volunteered at Mind and various music festivals, including Village Green Festival, as well as being secretary at her local AAT Essex branch.

"Time management is key. When you volunteer, people have to respect you're giving up your free time, and you have to respect that too. Make sure you get your work done, but know where your limit is. It's knowing when to communicate. You can't burn yourself out in the process of trying to help people."

Duffee is passionate about helping people and making an impact. "You only have one life," she says. "So do what you can to make a positive impact on the lives of other people." ■
